

## **DEXUS STANDARD COMPETITION TERMS & CONDITIONS**

### **GALLERIA / GALLERIA MONEY GRAB Terms and Conditions**

1. These terms and conditions are for all entrants who enter the Galleria Money Grab Centre Promotion (“Promotion”). Participation in this Promotion is deemed acceptance of these Terms and Conditions.

#### **ELIGIBILITY**

## HOW TO ENTER
